



**Memorandum of Understanding
Between
Rajamangala University of Technology
Phra Nakhon
Kingdom of Thailand
and
CLP Set Silver Leasing Co., Ltd.
People's Republic of China**



On Information Technology Collaboration

This memorandum of understanding (MOU) is completed at Rajamangala University of Technology Phra Nakhon on the 7th November 2018. The MOU expresses a cooperation between the Rajamangala University of Technology Phra Nakhon, located at 399 Samsen Road, Vajira Payaban, Dusit, Bangkok 10300, Thailand, which will be subsequently called "RMUTP" by Associate Professor Supatra Kosaiyakanont, the President, and CLP Set Silver Leasing Co., Ltd., located at Room935, Indongcheng district of Beijing Marriott Executive Apartments, Beijing, which will be subsequently called "CLPSSL" by Miss Wu Rong, General manager.

Rajamangala University of Technology Phra Nakhon, Kingdom of Thailand and CLP Set Silver Leasing Co., Ltd., People's Republic of China hereinafter referred to as the "Parties" have agreed to promote Information Technology collaboration. The Parties have reached the agreement as follows:

1. The Parties shall encourage the following activities:

CLPSSL education information-based solutions

- 1.1 Student work management system;
- 1.2 Teaching management system;
- 1.3 Office automation system;
- 1.4 Digital campus intelligent terminal system;
- 1.5 Mobile recording system.

2. Specific agreements or Memorandums of Understanding for implementing this Memorandum of Understanding shall be signed separately after negotiation on the detailed programs between the Parties.

3. All activities resulting from this Memorandum of Understanding shall be governed by and in accordance with the laws and regulations of the Kingdom of Thailand and the People's Republic of China. All agreements and obligations of the Parties are subject to the procurement and maintenance of all applicable government consents, permits, authorizations, and approvals.
4. This Memorandum of Understanding shall be governed by in accordance with the law and regulation of the Kingdom of Thailand and the People's Republic of China as well.
5. This Memorandum of Understanding is valid for five years and may be revisable or extendable by mutual consent. Either party may terminate the Memorandum of Understanding at any time by written notice signed by an appropriate official of the party initiating the notice. The notice must be received by the other party at least six months prior to the effective date of termination. The termination of this Memorandum of Understanding will not affect the implementation of on-going activities and/or programs undertaken pursuant to this Memorandum of Understanding, prior to the date of termination of this Memorandum of Understanding unless otherwise jointly decided upon by the Parties.
6. Any dispute or differences arising out of the interpretation or implementation of this Memorandum of Understanding shall be settled amicably through consultation between the Parties.
7. This Memorandum of Understanding shall be effective, when the representatives of the Parties have affixed their signatures.
8. If there is any dispute, it will be decided by the International Arbitration Center of Singapore or the New York International Arbitration Center.

The information, permission, or agreement under this MOU must be communicated by an official letter.

There are two copies of this MOU with the same wording that both parties thoroughly read and understand, and agree on all the purposes. Therefore, both parties sign and stamp (if any) it for further reference
